## Background

The European Union's Carbon Border Adjustment Mechanism (EU CBAM), fully operational since January 2026, imposes a price on the carbon emissions embedded in imports of products such as steel, aluminium and others. While the cost and compliance challenges of the EU CBAM persist, other countries have also declared their carbon pricing measures. The United Kingdom, for instance, has announced the imposition of its Carbon Border Adjustment Mechanism effective from 1 January 2027 (covering identical sectors as the EU CBAM).

Carbon pricing measures usually pose challenges to competitiveness for the industries in developing countries. The monitoring, verification and reporting requirements add to the logistical complexities and compliance costs. Proportionate pricing, combined with the current offset mechanism, such as Article 9 of the EU CBAM Regulation, has also been a point of discussion.

At the domestic level, India's Carbon Credit Trading Scheme (CCTS), notified in 2023, will gradually place a price on carbon emissions across nine key industrial sectors, which include the EU CBAM-covered sectors. Bearing in mind the differences between the Indian CCTS and the EU CBAM, there remains scope for deliberation regarding the trajectory that the CCTS must take to increase its cost efficiency in line with the global benchmarks.

Currently, it appears difficult to repatriate revenues accruing from measures like EU CBAM to developing or least developed countries. This issue raises challenges related to WTO consistency, adherence to fundamental principles of taxation, and integrating the element of equity.

## Background

Regulations like the EU CBAM raise interesting questions and offer potential for what countries can accomplish as trade partners. Can trade agreements play a pivotal role in navigating the challenges regarding accreditation and verification mechanisms? What role do instruments such as Annex 14 A of the India-EU FTA play in bridging the regulatory divide?

In the above backdrop, this Panel will delve into the following questions:

1. In what ways does the EU CBAM affect Indian exports? What are the key administrative challenges?
2. Can parameters other than price be viable options for establishing equivalence of carbon pricing measures?
3. What should be the role of domestic agencies in enhancing preparedness of the domestic carbon measures in the short and long term? How can the India-EU FTA, through Annex 14 A, help address such challenges?
4. How can the revenue collected through carbon pricing measures be directed towards decarbonisation efforts of the exporting countries?
5. What steps can countries take to conceptualize a global carbon pricing mechanism? Is global carbon price a distant reality?

He advises the government on International trade, investment, and dispute settlement-related matters, and has represented India in WTO disputes and FTA negotiations. He holds a doctorate from NLSIU, Bangalore. He has widely published in trade law related issues, including a co-authored book titled, 'International Economic Law: Texts, Cases and Material' (CUP,2021). In addition, he is a Co-Chair of the South Asian International Economic Law Network and was appointed as the India Chair of WTO Chair Programme in 2022.

**Prof. R. Sudarshan** is an economist and scholar with a distinguished career in research, development, and governance. He holds master's degrees from the Delhi School of Economics and the University of Oxford. He was also elected for a research fellowship at the University of Cambridge. He has held key roles with the Ford Foundation and UNDP in India, Jakarta, Oslo, and Bangkok, focusing on governance, human rights, and legal reforms.
